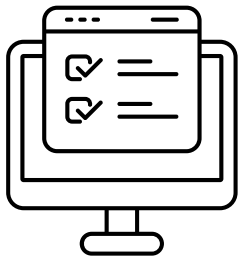

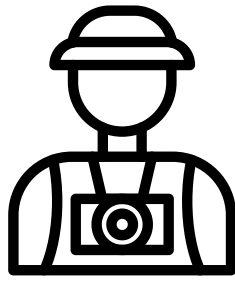

Foundation 2024 Activities

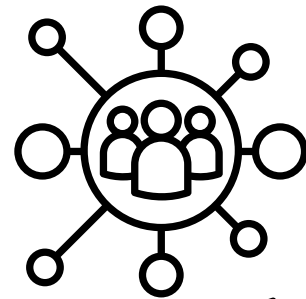
The Army Heritage Center Foundation continued its efforts in 2024 to support the U.S. Army by advancing the development of the U.S. Army Heritage and Education Center (USAHEC); promoting the Center as a major research center and tourist destination; and enhancing its collections, programs, and outreach. In 2024, the Foundation expended \$153,732 to support these objectives.

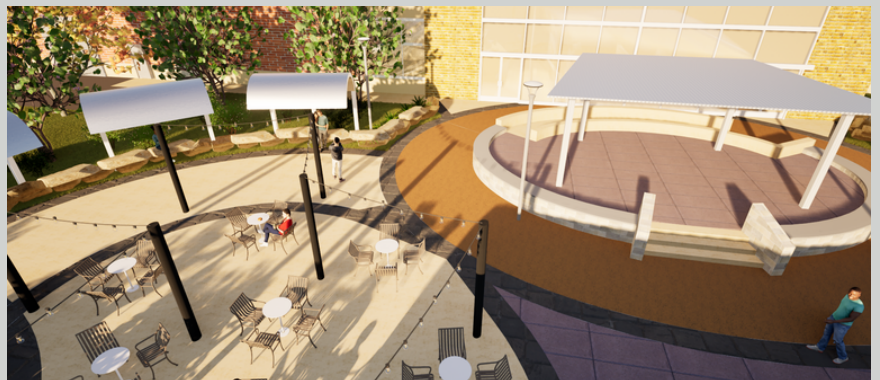


Outreach

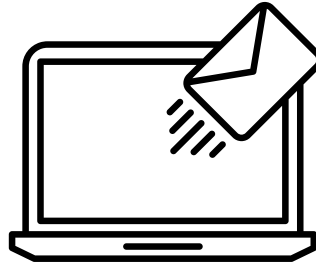

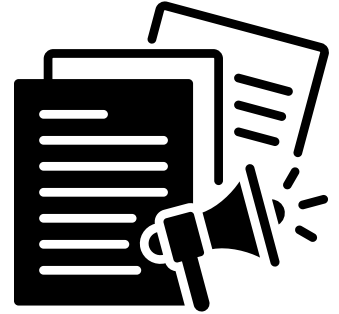

We also continued to draw interest in visiting USAHEC through special events and programs. In May, we partnered with the Redstone-Huntsville Chapter of AUSA to host a panel discussion - Operation Eagle Claw with Veterans of the conflict in Huntsville, Alabama. All proceeds from the event benefitted our organization and The U.S. Veterans Memorial Museum in Huntsville.



In June, the Foundation's Army Birthday program was held featuring a live outdoor performance by the Carlisle Town Band. During the event, we also presented awards to two special longtime supporters of the Foundation. Howard Kramer received the MG John Armstrong Award and George Fischer received the BG Joseph McCarthy Visionary Leadership Award. In October, we attended and had a booth at the annual AUSA Convention in Washington, DC. Our annual membership and recognition dinner occurred in late October where we honored First Troop Philadelphia City Cavalry with our Living Legend Award. The Foundation also honored the Honorable Thomas Corbett with the MG John Armstrong Award for his work as Pennsylvania Governor to support our mission.



The Foundation's education programs were evaluated and curtailed to avoid overlap and competition for audiences with USAHEC. The Veterans Café concept lived on with a June 2024 talk by MG Gregg Martin, USA Ret. focusing on mental health needs of soldiers and veterans. Attendance to that event was the largest we've had for that program. In September, the Foundation hosted the 28th Infantry Division Band for a rousing performance.



Enhance

The Foundation's primary focus, separate from the fundraising for public facilities, to enhance USAHEC was our continued support in obtaining, assessing, and processing of books, manuscript, and archival collections for transfer into the Center's collections. In 2024, the Foundation staff processed more than 100 collections of library and manuscript materials.

To promote the study of history, the Foundation again managed the National History Day in Pennsylvania (NHD in PA). Foundation staff working with our partners facilitated regional contests and planned and executed the state contest, which was held in person, at the University of Scranton and supported 595 students and student teams and resulted in 60 qualifying for the National contest held at the University of Maryland in College Park. Pennsylvania students attending the National contest earned 2 awards and 1 third place entry. The Foundation managed the National History Day in PA state competition for our last time. The program lives on but we worked to more closely align our programs with our mission to support USAHEC.



The Foundation continued to support ROTC cadets' commissioning programs by assisting ROTC programs to meet U.S. Army Cadet Command's requirement for senior Cadet staff rides. The Foundation continued its partnership with selected and specially trained staff ride facilitators at Gettysburg National Military Park. During 2024, the Foundation performed 20 staff rides, supporting 25 university ROTC programs and more than 500 senior cadets. On the cadets' stop at USAHEC, the Foundation stressed how the newly commissioned officers could access and use the collections to support their unit's needs. Toward the end of the year, we proudly announced the creation of an endowment fund through the generous donation of Robert and Nancy Gessner, in honor of Nancy's father, COL Donald Esper. Planning began on expanding the ROTC program nationally and including admission to the Gettysburg National Military Park exhibits and movie.



The Foundation also worked with USAHEC and Juniata College on the Hessian Powder Magazine Archaeology project in preparations for the Army's 250th birthday in 2025. The Foundation funded the Historical Structures Report created by Juniata College professor Dr. Jonathan Burns and his students.

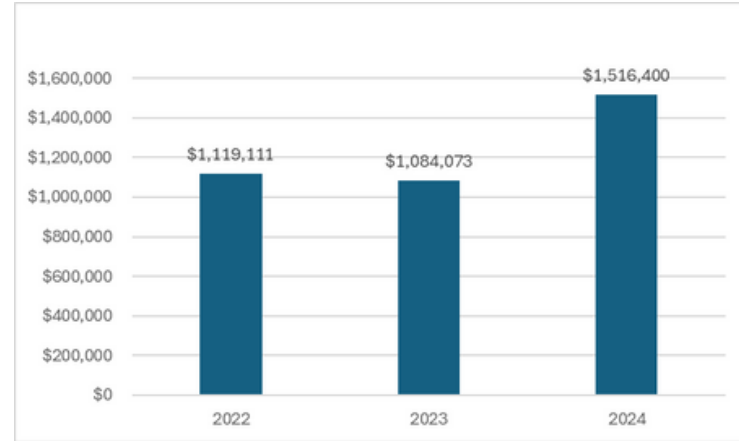

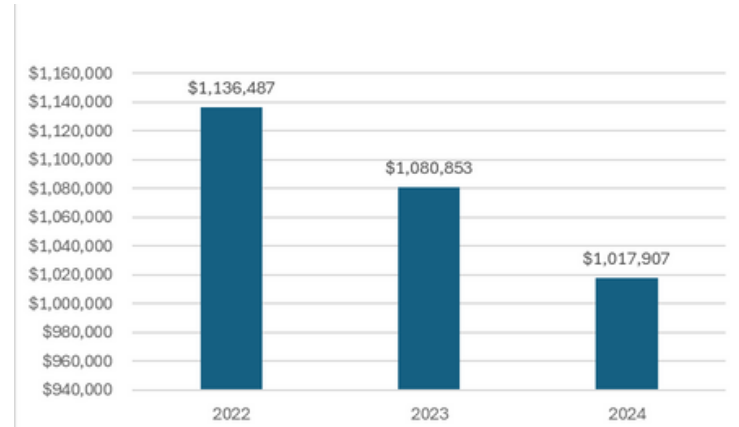


Total Revenue & Other Support over the past three years.

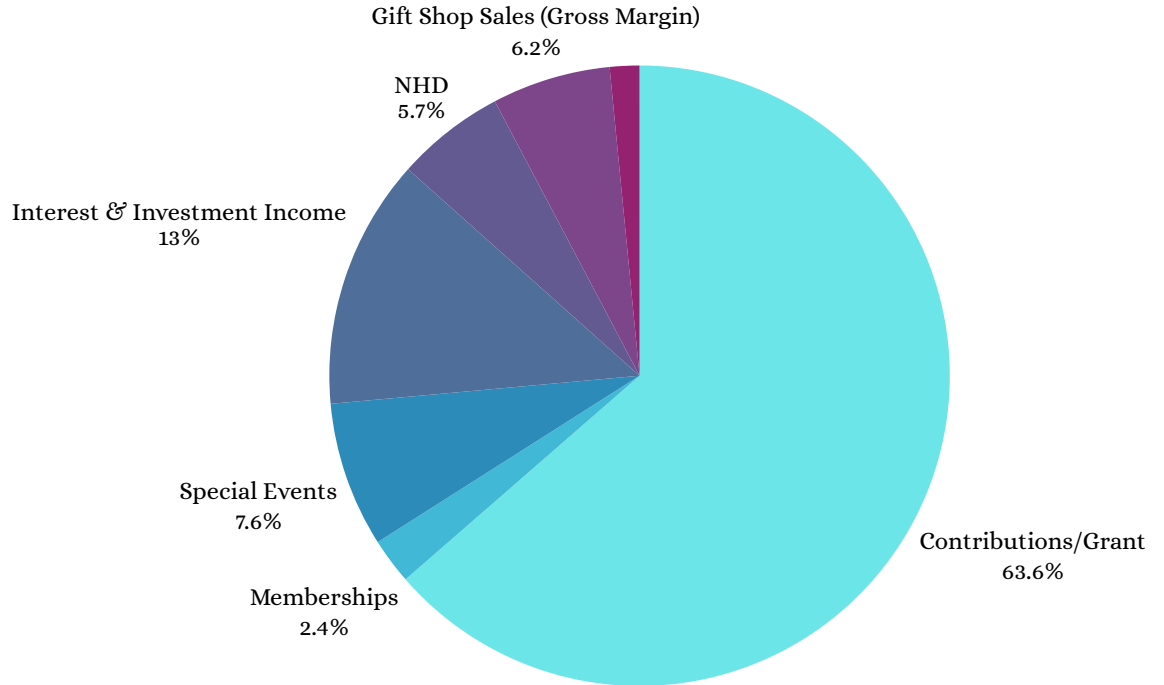

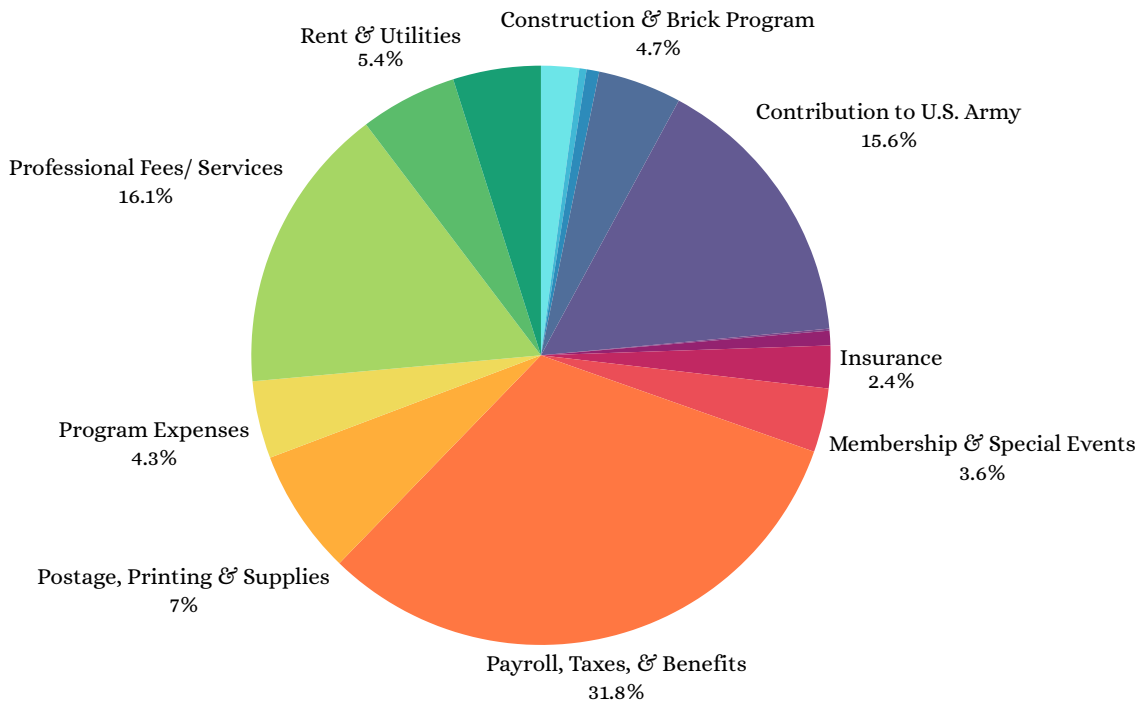


Total Expenses over the past three years.
