## **AMERICAN FRONTIER**

Apparently no 18th century intelligence theory existed for coordinating the collection and evaluation of information about the enemy, terrain, and weather. Although the value of intelligence was appreciated during the Revolutionary War, especially by George Washington, intelligence duties were loosely defined, and their accomplishment depended on individual commanders. Spies and rangers appear to have been chief providers of intelligence information. Other intelligence sources included exploration and mapping expeditions. See:
